SECTION 4: FIRST AID MEASURES**4.1 Description of First Aid Measures****First Aid**

Inhalation: Remove person to fresh air. If irritation occurs or symptoms develop, get medical attention.

Skin contact: Remove contaminated clothing. Wash skin with soap and water. If irritation develops and persists, get medical attention. Launder clothing before reuse.

Eye contact: Immediately flush eyes with water while lifting the upper and lower lids. Get medical attention if irritation persists.

Ingestion: Rinse mouth with water. Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to a person who is unconscious or convulsing. Get medical attention if symptoms develop.

4.2 Most important symptoms and effects, both acute and delayed: May cause mild eye and skin irritation. Ingestion may cause gastrointestinal distress with nausea and diarrhea. Inhalation of mists may cause upper respiratory tract irritation.

4.3 Indication of any immediate medical attention and special treatment needed: Immediate medical attention is not generally required.
