4. FIRST-AID MEASURES

5. FIRE-FIGHTING MEASURES

Extinguishing media: Use water fog, alcohol foam, carbon dioxide or dry chemical to extinguish a fire involving this product. Do not use solid water stream as this may spread the fire.

Specific hazards arising from the chemical: Product is not flammable or combustible but may burn in a fire. Combustion may produce carbon oxides.

6. ACCIDENTAL RELEASE MEASURES

Do not cut, weld, braze, drill, grind or expose such containers to heat, electricity or any other source of ignition. They may explode and cause injury or death.

Conditions for safe storage, including any incompatibilities: Store in a dry, cool, well-ventilated area. Keep in original containers. Store away from oxidizing agents.
